



Announcement from Yasothon Municipality

Subject: No Gift Policy

Fiscal year 2024

According to the Organic Act on Prevention and Suppression of Corruption B.E. 2018, Section 128, paragraph one, No government official is allowed to receive property or any other benefit that may be calculated as income from anyone. In addition to property or benefits that should be obtained according to laws, rules or regulations issued by virtue other provisions of the law. Except for receiving property or of any other benefits in accordance with ethics. According to the criteria and numbers set by the NACC and according to the Cabinet resolution on December 8, 2020 which approved the national reform plan for preventing and suppressing corruption and misconduct. (Revised Edition) By setting up a drive to carry out important reform activities. (Big Rock) Reform activity number 4: Develop the Thai bureaucracy to be transparent. Without benefit which goal number 1, item 1.1 "Every government agency must declare itself to be an agency where all government officials will not accept gifts and presents of any kind in the performance of their duties. (No Gift Policy)" In addition Yasothon Municipality has announced its intention to manage the honest work of Yasothon Municipality As a measure to develop the agency for officials to follow along with the regulations and other regulations and to drive reform activities according to the national reform plan above. Creating transparency within the agency creates values in performing duties and should practice it as an honest culture of Yasothon Municipality

Therefore, to strengthen the culture honest values and avoid actions that affect judgment or decisions in performing duties that lead to discrimination or conflicts of interest Yasothon Municipality has therefore established a policy for all executives, employees, officials, and personnel under their supervision not to accept gifts and gifts of any kind from the performance of duties (No Gift Poligy) on all festivals and special occasions. By giving the executive team municipal council member Municipal employees, regular employees, and hired employees all types under the jurisdiction of Yasothon Municipality Follow the guidelines as follows:

1. Refrain from receiving or giving gifts, gifts of any kind or any other benefits. From performing duties or in exchange for performing duties.
2. Must not ask or seek to obtain gifts. All kinds of gifts or any other unlawful benefits.

3. Do not...


3. Do not consent or agree with family members to give or receive gifts. All kinds of gifts or any other benefits to those involved in the work

4. There is no conflict of interest in performing work as well as benefiting oneself or their own people which causes damage to the government or through corruption

5. in the case where government officials under the Yasothon Municipality were found to have committed the said offense. Yasothon Municipality will take serious punishment. This is accepted in cases of necessity and unavoidability. Must follow the rules for receiving gifts or other gifts and benefits according to the regulations of the Office of the Prime Minister regarding giving or receiving gifts. Government officials, B.E, 2001, together with the announcement of the National Anti - Corruption Commission on the criteria for receiving property or other benefits according to the ethics of government officials B.E. 2020

Therefore, this announcement has been made for everyone's Knowledge and for all executives, officers, and personnel under their jurisdiction to continue follow the policy.
